## Year 12 and 13 Voluntary Contributions

### Yr12 and 13 curriculum provision and voluntary contributions

Each subject area will manage their own resources and/or visits and any voluntary contributions can be made via ParentPay.

### Improving facilities and resources at QEGS

We are fortunate to have had secure finances for a number of years and our sports, technological, scientific, artistic and performance resources are some of the best in the area. However, we are not complacent and we aspire to have 'world-class' facilities so that students can excel in their areas of interest. You may well have seen a number of stories in the local and national press and on television about school funding recently and will therefore be aware that the current situation is extremely tough. Whilst, at Queen Elizabeth's Grammar School, we have managed to make significant efficiency savings without impacting on the quality of provision for students, the reality is that it has become almost impossible to find the money to fund improvements of some of these excellent facilities. As a result, we need to be very pro-active in the face of these pressures and are working hard to try to raise more money for the school.
