

Dear Parent/Carer



The economic climate we are experiencing is challenging and will pose challenges for families, schools and all sectors of the national and indeed global economy. This letter serves two purposes:

Year 12 and 13 curriculum provision and voluntary contributions

During the course of Year 12 and 13, your child will be provided with numerous opportunities to opt into experiences and visits and/or to purchase resources to support and complement their chosen courses. Each subject area will manage their own resources and/or visits and any voluntary contributions can be made via ParentPay.

Improving facilities and resources at QEGS

We are also continually seeking to improve our facilities and resources at QEGS. We are fortunate to have had secure finances for a number of years and our sports, technological, scientific, artistic and performance resources are some of the best in the area. However, we are not complacent and we aspire to have high quality facilities so that students can excel in their areas of interest. You may well have seen a number of stories in the local and national press and on television about school funding recently and will therefore be aware that the current situation is extremely tough. Your help and financial support would certainly go some way to help the school and benefit the students. Thank you for your contributions in 2021/22, which enabled us to purchase additional resources for the Sixth Form including new furniture, books and IT equipment.
